THE AUCTION COMPANY WILL NOT BID ON BEHALF OF THE CONSIGNOR AND THE FOLLOWING FEE SCHEDULE APPLIES TO ALL ITEMS BOUGHT BACK BY THE CONSIGNOR:

- Items/lots bought back for **\$100.00 or less** per item/lot: **100%**
- Items/lots bought back for **\$100.01 to \$1,000** per item/lot: **25%**.
- Items bought back for **\$1,000.01 to \$2,000.00** per item/lot: **10%**
- Items/lots bought back for **\$2,000.01 or more** per item/lot: **5% of the last bid, not to exceed \$200.00.**
- **No-sale items/lots (lots not receiving any bids) will be charged a flat fee of \$25.00 per item/lot.**

1. Gates open daily for check-in **Friday, May 9th, 2025, through Thursday, May 15th, 2025, 8:00 AM to 4:30 PM***.

ALL SMALL CONSIGNMENTS (tools, pallet items) must be to the auction site by **Wednesday, May 14th by 4:30PM.**

ALL LARGE CONSIGNMENTS (tractors, implements, vehicles) must be to the auction site by **Thursday, May 15th by *12:00 PM (Noon)**

NOTE: AUCTION SITE WILL BE CLOSED FOR CHECK-IN SUNDAY, MAY 11TH, 2025

2. Consignors are responsible for delivery of their items to the auction site.
3. **CONSIGNORS ARE RESPONSIBLE FOR THE REMOVAL OF ALL "NO-SALE" ITEMS. THERE WILL BE A \$200 DISPOSAL FEE CHARGED FOR ANY "NO-SALE" ITEMS NOT REMOVED BY THE CONSIGNOR.**
4. All equipment must be removed from the auction site by **Wednesday, May 21st, 2025, at 4 PM. (Auction Site/Office closed Sunday, May 18th, 2025)**
5. **All vehicles consigned must be accompanied by the following at the time of consignment: NO EXCEPTIONS**
 - Title **must be** in consignor's name. Title and Bill of Sale must be signed or a Power of Attorney must be provided. Bills of sale are available online at DMV website or at auction site. Heavy diesel vehicles must have CARB notice included on bill of sale.
 - Current smog certificate (within 30 days of auction) for both gas-powered vehicles 1976 and newer and diesel-powered vehicles 1998 and newer.
 - Current registration or planned non-op certificate (**smog required even on non-op vehicles as described above**)
 - If a current smog certificate cannot be obtained, consignors must "junk" their vehicles with the DMV in order to be sold for parts. Follow the guidelines on CA DMV's website. (<https://www.dmv.ca.gov/portal/handbook/vehicle-industry-registration-procedures-manual-2/salvage-nonrepairable-junk-vehicles/junking-a-vehicle-individual/>)
 - Please be available to sign correct documents. **No vehicles will enter the auction site without correctly endorsed and complete documentation!**
6. The consignor does hereby indemnify and hold harmless the auctioneer and auction company from any and all claims of liability from injuries to persons or property of any type whatsoever caused prior to the auction, during the auction, or by removal of items purchased.
7. Mulrooney Auction Company is not responsible for any damages or thefts that may occur to consigned merchandise. The owner consigns the merchandise at his/her own risk.

Consignment checks will be mailed in approximately 3 weeks from the date of the auction. If we have to re-issue check for any reason (check expires, change who check is made payable to, etc.), there will be a \$30 re-issue fee.
